

## **HIGH END DIAGNOSTICS - TIMELY & FREE**

### **BACKGROUND**

In view of either unavailability of high end diagnostics or long waiting period for getting these tests done in 30 Delhi Govt. Hospitals and 23 Polyclinics, Governing Body of Delhi Arogya Kosh decided to provide financial assistance for high end diagnostic tests from identified DGEHS empanelled radiological/ imaging centres to patients, who are bonafide residents of Delhi, irrespective of their income status, undergoing treatment in the identified hospitals & polyclinics and referred by the Nodal Officer, DAK/ Incharge Polyclinic concerned.

### **ELIGIBILITY & DOCUMENTS**

Bonafide resident of Delhi, irrespective of income status , undergoing treatment in 30 Delhi Govt. Hospitals and 23 Polyclinics

Any one of the following photo identity proof document is to be submitted by the patient for residence proof:

### **MECHANISM OF REFERRAL**

The treating doctor advises for the requisite diagnostic test on the OPD slip which shall bear his signature, name & seal and send the patient to the HOD concerned for countersigning on the said slip. Thereafter, the patient goes to the Nodal Officer, DAK of the hospital concerned. Nodal Officer, DAK prepares the authorisation form after verifying the residence proof. He shall keep a copy of the authorisation form, relevant extract of the OPD slip (where the advice for the requisite investigation is mentioned and signature, name & seal of the treating doctor and HOD) and copy of the photo identity proof used for verification of residence.

*(Neither the treating doctor nor the HOD nor the Nodal Officer shall advice the patient to go to a particular centre. THE PATIENT IS FREE TO GO TO ANY OF THE IDENTIFIED DIAGNOSTIC CENTRE WITH THE REQUISITE TESTING FACILITY AS PER HIS/HER CHOICE. The list of the names of the identified centres alongwith the facilities available and name & mobile no. of the contact person shall be provided to the patient)*

### **AUDIT**

Nodal Officer/ Incharge shall send a weekly statement of referrals made to the HODs concerned and a monthly statement to Delhi Arogya Kosh through Medical Superintendent.
